Upon final approval from the Board an approval letter will be issued to the Owners Association of Sunset Village, Inc. ("Sunset Village") Applicant. Please note that each lot requires a separate Application and set of plans.

SUBMITTAL REQUIREMENTS

- **\$150.00 application fee.** \$150.00 application fee payable to the Owners Association of Sunset Village, Inc.
- **Dimensioned Site Plan.** This drawing should be drawn to scale and will show setbacks and all planned improvements, gates, fountains, etc. The Site plan shall also include the following. Please refer to the Design & Building Guidelines for a more detailed description and for any other requirements to be included in the Site Plan.
 - **Foundation & Framing Plan.** Plans shall be drawn at 1/4" scale and in conformity with all Gulf County and State of Florida codes.
 - **Drainage Plan.**
 - **Landscape Plan** 1" = 20' scale maximum.
 - **Tree Survey.**
 - **Floor Plans.** Floor plans shall be drawn at 1/4" scale, containing all information necessary for construction.
 - **Elevations.** Elevations shall be drawn at 1/4" scale. All exterior views of the structure must be shown and all exterior elevations of amenities such as walls, fountains, built-up planters, etc., shall be shown.
 - **Details.** Drawings shall show exterior trim, window, and door details, railings, planter construction, site walls, and all other exterior amenities.
- **Construction Schedule.** The schedule shall start with the date of ARC approval. The schedule shall list the estimated date of the Gulf County building permit, start of construction, end of construction, end of landscaping and issuance of certificate of occupancy. The owner's contractor shall endorse the schedule.
